Skills-Based Volunteer Projects



January-October — Host a Life Skills Class

Host a conversational life skills class to share your industry expertise with our young adults & moms transitioning into independence. Class topics centered on program needs. Hosted on 4th Thursday from 6pm-8pm of each month between January-October at 4KIDS Fort Lauderdale headquarters. Provide brief bullet points of discussion content for invite.
